# Declaration on the processing of personal data in the context of participation in courses organised by the *Future: Careers and Competencies Section (ZKK)*

### 1. Purpose of the data processing

Your data will be processed to facilitate your registration and participation in ZKK courses. ## 2. Ways in which the data is processed and categories of the processed personal data

Processing of your personal data extends to data collection, data storage and data deletion. The data thus processed includes your form of address, given name(s), family name(s), telephone number, e-mail address, academic title (if applicable), associated chair/organisational unit, street, house number, postcode and town/city. This is done for all participants in ZKK courses.

### 3. Legal basis

Article 6(1)(a) and (e) GDPR, Art. 4 ff. BayDSG and Art. 2(1)(3) BayHIG.

# 4. Recipients of the personal data

Your data will not be passed on to third parties.

# 5. Data retention period

Personal data is generally deleted at the end of the semester in which the data was collected. Otherwise, the data will be deleted as soon as it is no longer required for the purpose for which it was collected.

### 6. Rights of data subjects

Under the prevailing legal framework you can assert the following rights against the data controller:

- Right of access (art. 15 GDPR)
- Right of rectification (art. 16 GDPR)
- Right to erasure (art. 17 GDPR)
- Right to restriction of processing (art. 18 GDPR)
- Right to data portability (art. 20 GDPR)
- Right to object to the processing (art. 21 GDPR)
- Right to withdraw consent (art. 7(3) GDPR)
- Right not to be subject to automated decision-making (art. 22 GDPR)
