3) Purpose and legal basis of the data processing

Your data will be processed on the basis of *art. 6(1)(a) GDPR*, exclusively for the purposes of your application for a one-off payment from the Ukraine Emergency Fund of the University of Passau.

4) Recipients of personal data

Your personal data will be processed electronically, exclusively for the purposes of your application for payment from the Ukraine Emergency Fund. Your data will only be forwarded to the members of the committees of the University of Passau involved in the selection process and the staff members of the University of Passau tasked with the technical administration of fund; the data will not be forwarded to any third parties without your express consent.

5) Transfer of personal data to a third country

Your personal data will not be transferred to a third country.

6) Data retention period or criteria for determining the data retention period and deadlines for the review thereof

Your data will be stored for a maximum of one year starting from the date of acquisition.

7) Rights of data subjects

If your personal data is processed, you have the right of access to your personal data stored by us (art. 15 GDPR).

Where the personal data processed are inaccurate, you have the right to rectification (art. 16 GDPR).

If the legal requirements are met, you have the right to erasure (art. 17 GDPR), restriction of processing (art. 18 GDPR) and the right to object to the processing of your data (art 21 GDPR).

If you have consented to the processing of your data or entered into a data processing contract and the data processing is carried out using automated processes, you may have a right to data portability (art. 20 GDPR).

If you make use of the above rights, the University of Passau will check whether the legal requirements are met.

8) Right of complaint to the supervisory authority
