- You must **generally register** for all exams you intend to sit in a given semester during the registration period. You will not be allowed to sit an exam for which you have not registered.
- Applications for mark improvement [German] should be submitted to the Examinations Office.
- Please confirm that you have **successfully** registered for your exams using the interface or the "Registered exams" list and print out the list.
- Check the relevant chairs' websites to see if there are any additional registration modalities.

### Notes on resits during a leave semester:

- During your leave semester, you may only resit exams you have previously failed.
- You cannot resit passed exams for mark improvement during a leave semester.
